DanChurchAid (DCA) is a Danish humanitarian, non profit organisation based in Copenhagen. Established in 1922, DCA has its roots in the Danish Evangelical-Lutheran Church. DCA's faith-based foundation and values still guide our moral compass and we work based on a belief that all humans are created equal with inherent human rights.

WHAT WF DO:

DCA envisions a world without hunger, poverty, or oppression where political and popular powers work for a just and sustainable use and distribution of resources. We strive to fulfil this vision by achieving the following global goals:

Save lives: DCA seeks to facilitate locally led and owned actions of the individuals and communities affected by conflict, crisis, and displacement to protect themselves, prevent, withstand and recover from shocks, and live dignified and peaceful lives. Across this work, DCA aligns and incorporates protection approaches and human rights principles of diversity and inclusion to provide support for communities in improving their protection and psychosocial wellbeing. At the same time, DCA's Humanitarian Mine Action activities continue to play a critical role in reducing the threats posed by explosive remnants of war to people's safety and their socio-economic well-being through clearance of explosive hazards, risk education as well as victim assistance.

Build resilient communities: DCA provides a platform for strengthening the social, economic, and environmental resilience of people in vulnerable situations through disaster risk reduction, climate resilience and livelihoods interventions. Taking a locally led approach, DCA engages communities in the design and implementation of resilience measures, including anticipatory action. We also work to promote systemic changes in food and market systems. To this end, DCA continues to advocate for responsible business conduct, just and sustainable food value chains and to be a strong voice in the climate policy discussions.

Fight extreme inequality: DCA strives to empower individuals facing marginalisation, strengthen democratic institutions and promote the role of civil society and human right defenders amidst a global democratic decline and the erosion of the rule-based world order. This is done through close collaboration with our partners and through projects supporting individuals to meaningfully participate in public processes, enhance the protection of human rights in both online and offline spaces, and push back against laws and policies that intended to curtail and/or erode civic space.

Create engagement: Creating engagement with individuals, partners and stakeholders in Denmark is a vital part of our efforts to gain public support and secure diverse funding to achieve the global goals of saving lives, building resilient communities, and fighting extreme inequality. DCA does this by creating strong relations through shared values and solutions that allow individuals, partners, and stakeholders to take meaningful action. DCA also continues to engage with decision-makers and opinion-makers in Denmark and to be an active voice in the debates about Denmark's international development and climate policies.

HOW WE WORK:

Being a multi-mandated organisation, DCA works across the humanitarian-development-peace nexus to achieve sustainable change on the ground. DCA operates in contexts that are increasingly affected by a complex combination of factors, including protracted conflicts, different forms of displacement, fragility, and environmental changes. Our extensive and diverse partner network enables us to respond to multiple needs and create systemic change at local, national, and international levels for the benefit of people and communities with whom we work.

Localisation and Grand Bargain: As an organisation committed to localisation and as a signatory to the Grand Bargain initiative, DCA work is guided by our Local Leadership Strategy with an aim to shift more power, resources, and responsibility closer to local communities while strengthening accountability, power sharing, and equitable partnerships with relevant actors.

Human Rights-Based Approach (HRBA): Human rights are the foundation for all DCA's work with HRBA being integrated into programming through promoting the principles of Participation, Accountability, Non-Discrimination, Empowerment and Linking to Human Rights Law (PANEL). DCA's HRBA focuses on the needs, rights and dignity of people living in poverty and marginalised groups and we work with both rights-holders and duty-bearers. In fragile contexts, HRBA is translated into the mainstreaming of protection principles which mirror the PANEL principles.

Innovation: For DCA innovation is an intentional and systemic approach that combines creative thinking, shared values and collaborative tools to discover new or improved solutions that address critical social and/or environmental challenges. We aspire to integrate the mindsets, approaches and methodologies of innovation into our existing operations and practices. All DCA innovation initiatives are human-centred: they prioritise understanding the lived experiences, needs, and aspirations of those affected by the problem we are working to solve.

Climate and environmental sustainability: DCA works with climate and environmental sustainability both as a cross-cutting priority for our projects and programmes, and as a dedicated focus area of our work to build resilient communities. DCA integrates climate-related risks analysis in our interventions, while seeking to systematically assess and mitigate the environmental impact of our work. DCA also mobilises and engages communities to design and implement locally led climate mitigation and adaptation measures and increasingly supports recovery from climate-related losses and damages. We apply our on-the-ground experiences to our advocacy efforts at national, regional and global levels.

Gender equality and engagement of young people: DCA operates in complex contexts where pushback on women's rights and marginalisation of young people pose increasingly important challenges to obtaining long-lasting and equitable change. DCA therefore applies gender equality and engagement of young people as the two more cross-cutting priorities across all of our programmes and partnerships. This is done through advocating and communicating on the importance of gender equality and engagement of young people and through capacity sharing and strategic partnerships aimed at enhancing DCA's and partners' accountability in delivering on these priorities.

PARTNERSHIPS:

Working in partnerships has been at the core of DCA's work since DCA was established. Today, DCA works with a variety of partners including civil society organisations, faith-based organisations, social movements, research institutions, private sector, international organisations and government entities. Working through such partnerships, DCA has been increasingly playing a role of facilitator, connecting the various actors together to promote knowledge exchange, co-creation and capacity sharing. DCA is also committed to promoting local leadership and equal partnerships we continue to critically reflect on and address power imbalances through implementing our Local Leadership Strategy.

DCA has a cross-cutting partnership with the Danish Ministry of Foreign Affairs (MFA) building on extensive experiences and learning from many years of cooperation. Under the 2022-2025 Strategic Partnership Agreement with the MFA, DCA has been allocated a grant of DKK 200 million annually, making it the largest strategic partner to the MFA. The flexibility of this funding has also been instrumental for DCA to attract additional funding from other donors and diversity our funding base. In 2023, DCA's income exceeded DKK 1 billion testifying to the levels of trust and expectations attached to DCA in Denmark and internationally. Applying these funds to work together with our 198 partners, this enabled us to directly reach 5 million people in 2023.
